#### IGB GROUP POLICY ON FIT AND PROPER CRITERIA FOR DIRECTORS

# 1.0 PREFACE

Pursuant to the Main Market Listing Requirements (MMLR) of Bursa Malaysia Securities Berhad vide enhanced MMLR dated 19 January 2022, the Board of Directors of IGB Berhad (Board), has adopted the IGB Group Policy on Fit and Proper (FAP) Criteria for Directors (the Policy).

#### 2.0 OBJECTIVE

The objective of this Policy is to set out the FAP criteria based on which new directors proposed to be appointed and existing directors whose appointments are intended to be continued can be evaluated (referred to as 'persons').

#### 3.0 APPLICATION

This Policy applies to IGB and its subsidiaries (Group) in respect of appointment of directors as well as continuation of appointment of the directors on the boards of the Group.

#### 4.0 DELEGATION

- (a) The Nomination Committee (NC) of IGB shall be directly responsible for conducting assessments on the fitness and propriety of persons seeking appointment or re-election as a director of IGB, and making recommendations on their appointments.
- (b) The respective boards of subsidiary-level and joint venture (entities boards) shall be directly responsible for conducting assessments on the fitness and propriety of persons seeking appointment or re-election as directors of the entities boards, and making decisions on their appointments.

NC or the respective entities boards shall undertake due diligence in respect of such persons to ascertain the suitability on the basis of the qualification, expertise, track record, integrity of such person and also such other factors in respect of which information is obtained in the Declaration (Appendix A) or such other format which may be prescribed by IGB from time to time.

# 5.0 FAP ASSESSMENT

For the purpose of establishing whether a person is FAP prior to their initial appointment or reappointment as a director, the NC or the entities boards should have regard to the person's:

- (a) probity, integrity and reputation person should possess personal qualities such as honesty, integrity, diligence, independence of mind and fairness.
- (b) competence and capability person should have the necessary skills, experience, ability and competence to carry out the role.
- (c) financial soundness person should manage his/her debts or financial affairs prudently.

IGB shall have regard to the factors set out in the Declaration in assessing a person's fitness and propriety. The factors shall be assessed individually, as well as collectively, taking into account their relative importance. Failure to meet one factor does not necessarily mean failure to meet the FAP criteria. IGB should consider the specific circumstances surrounding a person's failure to meet specific factors, including the lapse of time since the occurrence of events, other contributing factors and significance of the event from the perspective of potential risks posed to the Group. Considerations relevant to the assessment of the fitness and propriety of the persons may vary depending on the degree of their influence and responsibilities in the affairs of the Group. The assessment process will involve a good measure of judgement, which should be exercised objectively and always in the best interests of the Group and the sound conduct of the Group's business.

### 6.0 POLICY AWARENESS

### 7.0 AMENDMENTS

This Policy may be amended, modified or supplemented from time to time to ensure compliance with any modification, amendment or supplementation to any modifications and directions issued by the regulatory authorities or under any other law applicable to IGB, from time to time.

The Board of IGB may issue/implement such guidelines, procedures, formats and/or reporting mechanisms to enforce this Policy as it may deem fit.
